Mr R Wheeler, commuter from Yate to Wotton under Edge, attended this meeting. Wickwar is experiencing increased traffic and speed. Mr Wheeler has been knocked off his motorbike at the Downs Road/Station Road junction. Mr Wheeler would like to see three way control traffic lights. Councillor Carroll has met with Mr Luke Hall, Member of Parliament for this area and has raised these and other road safety concerns for Wickwar.

Traffic control along the Downs road in the form of double white lines to prevent cars from overtaking, on this challenging road. Road speed reductions on the outer edge of the village from 40 to 30mph, along the Sodbury Road, travelling from Chipping Sodbury, also, a safe haven for walkers along the Sodbury Road towards Frith Lane.
