Ward Councillor M Lewis announced that in order to make the Planning Application PK16/4006/0 sustainable (application passed by committee December 2016) there is now a possible £365,000 available from potential developers (Section 106) for road traffic

improvements in Wickwar. But This will depend on a suitable developer taking on the site and agreeing to this proposal.

Part of this proposal is that money will be for the footpath travelling (Sodbury Road/Wickwar Road) from the Woodyard towards Frith Lane. It was also suggested that road traffic lights be erected on the Sodbury Road with push button crossing facilities to enable potential parishioners to access the village safely.

Architects for the refurbishment of the Town Hall have returned with some plans. Working party to consider the proposals put forward, Funding the project will be considered.

Funding for 2017/2018 will be £5000 and in 2018/2019 will be £3000. Total needed for the running of the Club is £17,000 per annum.
