E-consultations at GP practices

Many GP practices are now beginning to use telephone and email advice systems using their surgery website. Patients requesting advice before 5pm will get a response from clinicians on the following day.

This will speed up consultations and enable more appropriate service to be offered to each patient. More face-to-face consultation time will be freed up for those with more serious problems.

Cabinet response to Scrutiny Commissions Task and Finish Group on setting up a Housing Provision Company. Prepare a project and resource plan. Assess council owned land for possible development. Appraise feasibility for a stand-alone housing company. (Nov 2019) Cabinet response to Task and Finish Group on Provision of Emergency Accommodation Officers to identify suitable sites, look at different modular options, conduct a full costs appraisal.

Metrobus Cribbs-Patchway Extension Director of Environment and Community Services to start consultations with Network Rail to replace the Gipsy Patch Lane bridge and associated highway works.

Former Care Home – Woodleaze, Yate. To be made into a youth housing scheme run by Solon Housing Association. 20 self-contained units for 16-25 year-olds. Half of them leaving Care with higher support needs, and half young people from other backgrounds, some homeless.

S Glos Community Travel companies WECA has offered grant funding to the three local companies: Kingswood Comm Transport, Four Towns and Vale Link Comm Transport, plus Green Community Travel. Each should receive enough for 2 new vehicles Public Consultation on 2019/20 budget is open until 31Dec.
